## Combermere Craft Cabin

### Vendor Agreement 2014

The jury will accept items handmade by the applicant who lives within 100km radius of Combermere. Items are to be of original design, and are clean and new. Items are appropriately priced and labeled with care instructions, fibre content, etc. Edible items are packaged in new containers according to OMH regulations. Items are accepted/declined solely at the discretion of the jury based on the Mission Statement and Vendor Agreement. Any one member of the jury may accept items; all three must agree to decline. Items may only be entered for two years. All decisions are final.

COMMISSION will be paid as follows: 25% of all sales or 15% of all sales plus 35-55 volunteer hours or 5% of all sales plus 56 volunteer hours.

ANNUAL MEMBERSHIP FEE of \$20.00 is required **WITHOUT EXCEPTION**.

Payment for items sold, less commission, is made at the end of the season (early October) unless requested from the Co-operative Treasurer at the end of July.

The Township of Madawaska Valley and the Combermere Craft Cabin do not insure arts and crafts at the cabin gallery. Check your personal insurance, it is likely that it covers your work while outside your premises.

Work may not be removed from the Cabin during the season (May – October) unless arranged with one of the stock managers.

Displays are the sole responsibility of the stock managers and co-op members are not allowed to rearrange their own items.
